Red Deer, Alberta - Mr. Peter Lacey, President and CEO of Cervus GP Ltd., the general partner of Cervus LP, announced that the board of directors of the general partner has approved a cash distribution to Cervus LP unitholders of \$0.08 per unit for the month of April. This represents \$0.96 per unit on an annualized basis. Payment will be made on or about May 15, 2006 to unitholders of record as of the close of business on April 30, 2006. The partnership recently acquired and is presently operating 5 construction equipment dealerships in Alberta that sell Bobcat, JCB and JLG equipment. The units of Cervus LP are listed on the TSX Venture Exchange and trade under the symbol "CVL.UN".
